Occupational Health Training with Animals (OHT-A)

<u>Step 1:</u> To complete your OHT-A training, log into WSU's MyResearch database (<u>https://myresearch.wsu.edu</u>). Go to **Compliance > IACUC > OHT-A Training**.

<u>Step 2:</u> Read and click the "Next" button (circled in red in Figure 2) to proceed with the training.

Occupational Health Training- Animals (OHT-A) is a risk-assessment and health protection service that is provided completely free of cost to assist individuals who work or come in contact with live vertebrate animals in course of their job, research, or training. Working with live vertebrate animals exposes personnel to a variety of zoonotic risks such as allergens and microorganisms that live with the animals. OHT-A is free for all WSU personnel. The program also provides a confidential assessment by a medical doctor as a part of its services. IACUC has mandated that OHT- A should be refreshed at least once every 3 years. However, individuals are welcome to make changes at any time and/or when required. For example, updating OHT-A is required if a person is working with new species. A change in health status of the individual also merits updating the OHT-A medical participation and assessment.
